## PRIMARY LOGO



**CORPORATE SIGNATURE** The Corbis corporate signature consists of the swirl combined with the logo type.

When placed on a white background, the color version of the logo should be used for print. There may be cases when colors need to be converted to CMYK.

## LOGO USAGE



**CONTROL AREA** Never crowd the logo, or place other elements in the control area. Control area measurement 1x is equal to the x-height of the "s" in Corbis.



MINIMUM SIZE To ensure legibility, the minimum size for reproduction of the Corbis corporate signature is 29 pixels (.40278") from the top of the swirl to the base of the swirl.

**ONE COLOR APPLICATIONS** If placed on a colored background, a one-color black, white, or grey version of the logo should be used.





**LOGO URL** The logo and url should always be in the above relationship.
